# **Utah Honor Flight**

Utah Honor Flight has been selected as a recipient of the Patriotism & Service award for their outstanding service in honoring Utah's WWII, Korean and Vietnam veterans. UHF is a non-profit organization dedicated to transporting Utah veterans to Washington, DC to visit the memorials that have been dedicated in honor of their service. Since its creation in 2013,

Utah Honor Flight has taken 983 veterans to date to Washington, DC to be honored and see their memorials, raising over a million dollars in funds to cover the costs of taking veterans on their Honor Flight journey. Board members, flight leaders, medics, and the flight preparation team are all volunteers, donating thousands of hours to Honor Flight's mission of serving Utah's veterans.



## **Tooele City Fire Department**

Tooele City Fire Department has been selected as an organization recipient of the Patriotism & Service award for their exceptional service and dedication to their community. Tooele City Fire Department is an all-volunteer department and contains 50 active firefighters and over 100 senior status firefighters who are on call 24/7/365 to handle emergencies that occur in Tooele City. Annually the department responds to between 400-500 fire, rescue and hazmat calls in Tooele City. In addition to their fire ground

duties they maintain a robust fire prevention and community service program where the volunteers donate thousands of hours to the citizens of Tooele City. During 2016, Tooele City experienced a very active fire season. On the evening of July 19<sup>th</sup> the department responded to a catastrophic fire in a local neighborhood. Some are calling it the communities 100 year fire. During the wind driven fire, 27 homes experienced damage. Members of the department courageously fought the fire preventing it from spreading to another 40 homes in the neighborhood. The department's involvement in suppressing the fire and the subsequent overhaul and clean-up was pivotal to Tooele City's success in handling the situation.

## **Officer Cody James Brotherson**

Officer Cody James Brotherson has been selected to posthumously receive the Patriotism & Service award for his unwavering devotion in serving his city, exhibiting integrity and bravery while upholding the Constitution and making the ultimate sacrifice in protecting the lives of the many individuals in the community he served. Cody Brotherson was a three-year veteran of law enforcement and served the people of West Valley as a West Valley Police Officer. Cody was determined to make a difference in the world, which is why he decided to become a police officer. He attended Salt Lake

Community College and graduated from the Police Academy in 2012. As an officer, he often carried soup and drinks in his car to give to those who were struggling when he came across them in the line of duty. An example of his selfless service was when he purchased a pair of new shoes for a homeless teenager he came across on a call. He told that teen he was going to come back in a year to hear how those shoes had changed his life and helped him get back on track. Cody loved traveling and exploring new places; he loved cooking and hoped to one day own a food truck and share his talent with the world.

Tragically, Cody was killed in the line of duty on November 6, 2016 leaving behind his fiancé, parents, and two brothers. Officer Brotherson was posthumously awarded the Medal of Honor for his bravery and sacrifice. Although Cody's life was cut short, he certainly made a difference in the world and positively influenced those he came in contact with.



#### Lorna Koci

Lorna Koci has been selected as a recipient of the Individual Patriotism & Service award for her outstanding service to the impoverished and homeless community of Davis County in her innovative leadership as Director of the Bountiful Food Pantry. Lorna has over 40 years of professional and leadership experience, initially working in the private sector technology field and then making a switch to state government and non-profit organizations. She worked for IBM for 20 years followed by running software companies for several years. She left the private sector to work for Governor Huntsman on the Utah

Commission on Aging, followed by serving as Programs Director at the Utah Food Bank for 3 years. She is now the Executive Director of the Bountiful Community Food Pantry where she is applying her leadership abilities and desire to help those in need. She lives in North Salt Lake with her husband Doug. She has six children and ten grandchildren and enjoys sailing, biking, quilting, smocking, gardening and music.

Lorna has served on the Open Legal Services Board of Directors and currently serves on the Davis County Aging Services Advisory Board and the Davis Community Learning

Center/Promise Bountiful Steering Committee and is active in other church and community organizations. She was the recipient of the 2015 Soroptimist Women of the Year Award for Davis County, the 2016 Most Distinguished Woman Award for Davis County and the 2016 Utah Enlightened Fifty Award.



## **Carol Hollowell**

Carol Hollowell has been selected as a recipient of the Individual Patriotism & Service award for her dedication and unwavering service to improving the lives of individuals living in poverty and homelessness in Southern Utah as Executive Director of Switchpoint. Carol Hollowell, native of Oregon, moved to St. George, Utah seven years ago. She graduated from Oregon State, has 4 adult boys, and is married to college sweetheart. Her desire to make a difference and change the model of homeless shelters in Utah led her on a course to open Switchpoint Community Resource Center. Over the last two years, Switchpoint has

added on a food pantry, a community garden, a thrift store and a rapid rehousing program.

With Carol at the helm of Switchpoint, families living in poverty and homelessness have received 464,160 pounds of food with 845 individuals benefiting from service, 103 having found employment and 266 people having secured housing. Plans for a 55 unit permanent supportive housing project are in the pipeline now. Throughout the last two years, she has received the Social Justice Award and Woman of Achievement in Public Service. In the fall of 2015, Carol and her husband, Bob, rode their tandem bicycle across the U.S., visiting homeless shelters and meeting individuals who are chronically homeless.
