It is adjudged that the defendant has been convicted on the following count(s):

Count 1 : Public Indecency

Count number 1 , Public Indecency, 163.465(2)(b), Felony Class C, committed on or about 09/06/2012. Conviction is based upon a Guilty Plea on 12/17/2013.

Sentencing Guidelines

The Crime Severity Classification (CSC) on Count Number 1 is 6 and the Criminal History Classification (CHC) is B.

The court finds substantial and compelling reason for a Downward Dispositional and Durational Departure, as stated on the record. This departure is pursuant to the following aggravating or mitigating factor(s):

- Stipulation of the parties.

Probation

Defendant is sentenced to Supervised Probation for a period of 5 year(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)):
Defendant shall:

- Supervised Probation: Report immediately to Jackson County Community Justice, 1101 West Main, Medford, OR 97501 within 24 hours of your sentencing unless you are in custody. If in custody, report within 24 hours of your release from jail.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Obey all laws.
- Not have contact with minors without the written consent of probation officer.
- Not have contact where minors congregate without the written consent of probation officer.
- Submit to polygraph examination by a qualified examiner and penile Plethysmograph as a condition of sex offender treatment program
- Submit to sex offender evaluation, participate in and successfully complete sex offender treatment if deemed appropriate by probation officer.
- Not have contact with Rogue Valley Mall without prior permission from the court.

If convicted of a felony or a crime involving domestic violence, you may lose the right to buy, sell, transport, receive, or possess a firearm, ammunition, or other weapons in both personal and professional endeavors pursuant to ORS 166.250, ORS 166.291, ORS 166.300, and/or 18 USC 922(g).
